Privacy Policy

It's Teldust A/S policy to respect your privacy any information we may collect while operating our websites.

What information do we collect?

We collect information from you when you fill in a form and submit it on our site. You may, however, visit our site anonymously without having to register or log in.

Like most website operators, Teldust A/S also collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, IP address and the date and time of each visitor request.

What do we use your information for?

Any of the information we collect from you may be used in one of the following ways:

• To respond to your inquiries, whether they are requests for quotations or just information.

Initial responses are usually by Camfil employees. If your request or inquiry calls for it, we may ask our sales representatives to contact you. Our sales representatives are independent companies.

- To improve our website (we continually strive to improve our website content based on the information and feedback we receive from you.)
- To improve customer service (your information helps us to more effectively respond to your customer service requests and support needs.)
- To send periodic emails

The email address you provide may be used to send you information and updates pertaining to your order, in addition to receiving occasional company news, updates, related product or service information, etc.

Note: If at any time you would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email.

Teldust A/S purpose in collecting non-personally identifying information is to better understand how Teldust A/S visitors use its website. From time to time, we may use non-personally-identifying information in the aggregate, e.g., by creating and learning from a report on trends in the usage of our website.

Do we use cookies?

Yes. Like many websites, we use cookies to obtain certain types of information when your web browser accesses some of our web pages. Cookies in themselves do not identify the individual user, just the computer used.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Teldust A/S uses cookies to help us identify and track visitors, their usage of our website, and their website access preferences. Teldust A/S visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using our website, with the drawback that certain features of our website may not function properly without the aid of cookies.

Google Analytics

Google Analytics is a web analytics tool that helps Teldust A/S understand how visitors engage with our website. We can view a variety of reports about how visitors interact with our website so we can improve it. Google Analytics collects information anonymously. It reports website trends without identifying individual visitors. All website owners using Google Analytics are required to have a privacy policy that fully discloses the use of Google Analytics.

Google Analytics Cookies

Like many services, Google Analytics uses first-party cookies to track visitor interactions. These cookies are used to store information, such as what time the current visit occurred, whether the visitor has been to the site before, and what site referred the visitor to the web page. Browsers do not share first-party cookies across domains.

Use of IP Address

Every computer and device connected to the Internet is assigned a unique number known as an Internet protocol (IP) address. Since these numbers are usually assigned in country-based blocks, an IP address can often be used to identify the country, state, and city from which a computer is connecting to the Internet. Google Analytics collects the IP address of website visitors in order to provide website owners a sense of where in the world their visitors come from. This method is known as IP geolocation. Google Analytics does not report the actual IP address information to Teldust A/S. Additionally, using a method known as IP masking, website owners that use Google Analytics have the option to tell Google Analytics to only use a portion of the IP address, rather than the entire IP address, for geolocation. Whether or not website owners use Google Analytics, they have access to IP addresses for visitors to their sites.

Personal Information

Personal information is information that personally identifies you, such as your name, email address or billing information, or other data which can be reasonably linked to such information. The Google Analytics Terms of Service, which all Analytics customers must adhere to, prohibits the tracking or collection of this information using Google Analytics or associating personal information with web analytics information.

Google's Use of Analytics Data

Teldust A/S have the control over what data we allow Google to use. We have decided share this data with Google by using the Google Analytics Data Sharing Options. These options allows to improve Google products and services. Teldust A/S can change these options at anytime.

Browser Opt-out

To provide website visitors more choice on how their data is collected by Google Analytics, Google has developed the Google Analytics Opt-out Browser Add-on. The add-on communicates with the Google Analytics JavaScript (ga.js) to indicate that information about the website visit should not be sent to Google Analytics. The Google Analytics Opt-out Browser Add-on does not prevent information from being sent to the website itself or to other web analytics services.

_utmz file

Stores the traffic source or campaign that explains how the user reached your site.

The cookie is created when the javascript library executes and is updated every time data is sent to Google Analytics.

Do we disclose any information to outside parties?

We do not sell, trade or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business (as stated above), or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or other rights, property, or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.
